On June 7, 2011, the Oneida County Sheriff's Department lost one of its own when **Deputy Kurt B. Wyman** was killed in the line of duty while he was attending a domestic dispute. Kurt passed away at the all too young age of 24. He left behind his wife Lauren, son Alexander and daughter Adyson, who was born on the evening he was tragically killed, as well as his parents and many other family members and friends.

Having also served in Iraq as a Marine, Kurt's life choices made it obvious that he felt the need to protect and serve others at all cost. He was also very dedicated to his family. The realization that his work was far from done inspired Kurt's family members, co-workers and several others in his community to form the Deputy Wyman Foundation. The foundation's goal is to build a park that would not only honor Kurt's memory, but carry on his tradition of caring and giving back to others.

The Deputy Wyman Foundation has partnered with the Town of Whitestown and is aggressively planning the development of the Kurt B. Wyman Memorial Park on Judd Road. The park will include new playground equipment for all ages, rest room facilities and multiple state of the art fields for soccer, another love of Kurt's.
